## **TERMS AND CONDITIONS**

- The Bride and Groom must sign this Wedding Video Contract before services are rendered.
- A **\$250.00 Non-Refundable Deposit** is required to secure a date.
- If the Wedding is cancelled or the date is changed, the initial deposit is forfeited. An additional Non-Refundable Deposit will be required to secure a new Wedding date.
- The balance of the account is due one week prior to rehearsal date unless prior arrangements are made. The entire balance **must** be paid before the Wedding Ceremony, **No Exceptions!**
- **Digital Memories** accepts Money Orders, Cashier's Checks, Personal Checks and Cash. There is a \$35.00 fee for any returned checks. If the Deposit is paid by Check and it is returned by your Bank, the contract is Void and the Date is no longer secured.
- It is the sole responsibility of the client to secure permission of the Church, Synagogue or other officials to film the ceremony. The deposit is non-refundable if such officials prevent filming. **Digital Memories** will abide by the rules of the Church or Synagogue regarding camera placement at the ceremony.
- **Digital Memories** will take utmost care to produce a tape of exceptional quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, and defective tape stock or client misuse of equipment. If filming is prevented due to such occurrences, all money paid will be refunded. **Digital Memories** makes no guarantees, either expressed or implied, in regard to the aesthetic qualities of the completed videotape since "aesthetic qualities" are based on personal opinions and vary from one person to the next.
- **Digital Memories** reserves the right to terminate contract for any reason at any time. Should **Digital Memories** terminate contract, all monies paid will be refunded in full.
- Under any and all circumstances, the total liability of **Digital Memories** is limited to the refund of the deposit.
- All Audio and Video footage is the copyrighted property of **Digital Memories**. **Digital Memories** reserves the right to use any and/or all footage for promotional purposes.
- The Video is strictly produced for the client's private home use only. Any duplication or broadcast (including internet use) without written consent of **Digital Memories** is strictly prohibited.
- Clients assume all liability for any form of copyright infringement.
- It is the Client's sole responsibility to inform **Digital Memories** of any specific needs or changes in events.
- A 7% Mississippi Sales Tax will be added to Packages and Additional Options if the Wedding is performed in the state of Mississippi. Mileage will be charged at a rate of \$0.50 per mile for weddings and/or wedding related events 25 or more miles from Southaven Mississippi.
- In addition to Mileage, a Travel Charge of \$25.00 will be assessed when Wedding related events occur further than 15 miles from each other.
- For Wedding and wedding related events in excess of 60 miles of Southaven Mississippi, a Travel expense of \$100.00 in addition to mileage will be assessed for appropriate lodging and meals.
